Documents Required	Applicant should have online version of all original certificates including mark sheets (matriculation onwards), experience certificate(s), monthly emoluments/salary drawn, other relevant documents (including one set of self-attested certificate(s)/document(s) and updated Curriculum Vitae.

	minimum essential qualification and experience laid down for the post. Qualification obtained has
	to be from a recognized University/Institute. Eligibility in terms of age, qualification and experience
	of a candidate shall be considered as on the date of Selection Process.
3	The number of vacancies indicated in the notification is tentative. IIT Dharwad reserves the right to
	increase or decrease the number of advertised posts at the time of selection. Further, IIT Dharwad
	reserves the right to NOT fill any of the posts advertised.
4	No TA/DA will be paid for attending the Selection Process.
